struggle with the dual concerns of the safety of their staff and the survivability of their business. Currently before the Senate, the **Real Economic Support That Acknowledges Unique Restaurant Assistance Needed To Survive** (**RESTAURANTS**) Act, if passed, would provide \$120 billion in relief through a grant program administered by the Treasury Department.

On December 7th, Patrice Cleary, owner of Purple Patch and faithful Village Partner, posted on their Facebook page:

Last year Purple Patch employed 74 people. For the 24 that I have managed to keep on staff, I remind them that this is about safety and survival right now and at any moment we can close. With #covid\_19 numbers going up and hospitals being overwhelmed with patients I am fearful that we may not be able to make it through the winter, despite all the safety measures that we have taken to try to stay open.

She urges individuals to support the RESTAURANTS Act.

# Seniors and Crime – Risks and Remedies from the DC Attorney General's Office

A recent attempted email scam\* involving a Villager highlights the importance of knowing what to watch out for, as thefts and scams are on the rise. At the quarterly WAVE meeting last month, the DC Attorney General's Office presented about COVID-related and other scams, as well as tenants' rights. DC AG Karl Racine introduced Amy Mix, lead attorney on the Senior Protection Team, and noted that he had upgraded this team from one and a half part-time attorneys to 30 Public Advocates, including 5-7 working on consumer issues.

Racine said that problems caused by COVID had triggered an anti-gouging statute. Under that statute, sellers of services cannot raise their prices more than ten percent. Sellers of products such as Personal Protective Equipment, gasoline, soap, or bleach cannot charge more than 165 percent over their usual prices. His office is receiving three times the usual number of complaints, most of them COVID-related.

Racine also said that he expects a "tsunami" of evictions as the moratorium expires (on November 30). This will be on top of the practice by some landlords of cutting utilities or maintenance so that tenants move out and the property can be re-rented at a higher base cost under rent control. He said that he would like to eliminate "street evictions" where a tenant's property is just left on the sidewalk.

addresses that do not match those that show up when you move the cursor over them, and poor spelling or grammar in a message allegedly coming from someone you know. Also, she advised Villagers to be wary of someone who shows up at your door claiming to work for a neighbor or "just being in the neighborhood" and offering to inspect your roof, walls, etc. or do the work for less because they have materials left over.

Mix said that there are too many scams and cons to cover in a brief presentation, but she offered to come back and do a more detailed presentation for individual Villages if asked. In the meantime, she offered these phone numbers to call for more help:

\*Recently, a Villager's email contacts list was stolen and used for fraudulent pleas to buy a gift card on line. The scammer claimed that our neighbor had a problem with his bank and would pay people back soon but needed to have the gift card sent to a friend for a birthday present. People "all over the world" detected the scam and called our neighbor to check.
